<u>Noted That</u> - the outcome of a Meeting and receipt of associated correspondence in connection with Debtor (A) was reported together with the outcome of discussions held between Officers and the Council's Solicitors.

Arising from same the consensus was that the Clerk proceed, under delegated authority, with the course of action proposed namely, to terminate the tenancy in accordance with the instructions of Council previously and then make the following offer to the former tenant in view of the circumstances outlined:

- To offer a new contracted out tenancy for a term of 3 years;
 and
- ii. The new lease to have a landlord break clause allowing termination upon 6 months notice; and
- iii. The payment of all arrears within 28 days; and
- iv. The payment of all Council legal costs within 28 days; and
- v. The tenant agreeing to sign a tenancy at will whilst the new tenancy is negotiated; and
- vi. The tenant agreeing to enter into a rent deposit deed in respect of three months' rent.
