### **TEMPORARY PROHIBITION OF THROUGH TRAFFIC & PARKING**

No person shall cause or permit any vehicle to proceed or wait on the sections of Affected Roads except for access to land or premises on or adjacent to those length of roads. Roads affected -

Bedford Square (up to but not including its junction with West Street, Drake Road and Duke Street), Canal Road, Market Road, Russell Street (from its junction with Garden Lane to its junction with Plymouth Road). Abbey Bridge, Plymouth Road, Road from Gulworthy Cottages past Gulworthy Farm (Slip Road between B3257 to A390)

The alternative, signed, route for vehicles travelling North to South will be via -

West Street, Duke Street, Brook Street, Parkwood Road, A386 Stannary Bridge Road, Dolvin Road, Whitchurch Road, Anderton Lane

The alternative route for vehicles travelling East to South will be via -

Whitchurch Road, Anderton Lane

### TEMPORARY PROHIBITION OF THROUGH TRAFFIC & PARKING

No person except a driver of a vehicle displaying an event permit shall cause or permit any vehicle to proceed or park on the sections of the roads detailed below, except for access to land or premises on or adjacent to those lengths of roads.

Roads affected -

Chapel Street, Garden Lane, West Avenue

## TEMPORARY PROHIBITION OF WAITING/LOADING, UNLOADING

No person shall cause or permit any vehicle to wait, load, unload or stop at any time on any day on any of the sections of Affected Roads.

Roads affected -

Anderton Lane, Brook Lane, Brook Street, Callington Road, Courtlands Road, Crelake Industrial Estate, Crowndale Road, Dolvin Road, Deer Park Close, Deer Park Lane, Deer Park Road, Down Road, Drake Road, Drake Villas, Duke Street, Ford Street, Launceston Road, Mount Tavy Road, Parkwood Road, Pixon Lane, Plymouth Road, Spring Hill, Stannary Bridge Road, Vigo Bridge Road, West Street, Westbridge Industrial Estate and Whitchurch Road

Glanville Road - West side of carriageway for entire length of street

## PROHIBITION OF THROUGH TRAFFIC (ONE WAY)

No person shall cause or permit any vehicle to proceed in a direction other than that indicated by the one way street signs on the sections of Affected Roads.

Roads affected -

West Street (North-Eastwards from its Junction with Spring Hill/Ford Street to its Junction with Drake Road/Duke Street)

Parkwood Road (North-Eastwards from its Junction with Brook Street to its Junction with the A386) Anderton Lane (Westwards for its entire length)

Road from Gulworthy Cottages past Gulworthy Farm (slip road between B3257 and A390)

#### **BANNED TURN**

No person shall cause or permit any vehicle to turn right on the sections of Affected Roads. Roads affected –

From Spring Hill making a right turn into Ford Street From Brook Street making a right turn into Vigobridge Road

From Rocky Hill making a right turn into West Street From Market Street making a right turn into West Street

From market Street making a right turn into west Street

# TEMPORARY SUSPENSION OF A PROHIBITION OF RIGHT TURN

The Prohibition of right turn will be suspended on the sections of Affected Roads. Roads affected –

Crowndale Road turning right at the junction with Plymouth Road
