2. New Councillor Event

As Members will be aware, a 'Prospective New Councillor Event' took place on Wednesday 8th March, in the Council Chamber. Six potential new Councillors attended, and received a presentation from the Town Clerk summarising the requirements of being a Councillor, as well as a background into the operation of Tavistock Town Council. The Mayor provided an account of the experience of being a Councillor and related key information.

3. Grants Presentation Evening

The annual Grants Presentation Evening took place on Thursday 16th March, 2023 in the Council Chamber, when representatives from the seven successful organisations received their Grant cheques from the Mayor. The event was also attended by the Town Councillors who form the Grants Panel.

The attendees enjoyed a light buffet, and networked, prior to the cheques being distributed. The event was held earlier than usual this year, due to the pre-Election period coming into force for the Town Council on 15th March 2023.

Overall, a total of £ 10,623 was awarded to a wide variety of organisations from across the town. The next Grant Application period will start in September/October 2023, with Grants being paid out in May 2024.

4. Former Mayor Graham Willis - Memorial Service

On Monday 27th March, a Memorial Service took place in the Council Chamber in memory of former Councillor, and Mayor, Graham Willis who died recently in France. Whilst living in Tavistock, Mr Willis had been very involved with the Pontivy Twinning Association, and actually retired to France living in a town only around 10 miles from Pontivy.

Mr Willis was Mayor in 1976 – 1977, and again in 1987 – 1988.

Approximately 20 family and friends attended the event, which had been arranged by former Councillor Willis' son Paul, together with the Assistant to the Town Clerk.

Pay Award 2023/2024 - as previously advised, the Employer Side had made a full and final offer to the staff side in connection with the 2023-24 pay settlement. This amounted to an award of £1,925 (pro rata as appropriate) to those posts on SCPs 2-43, an increase of 3.88% to those posts on SCPs 44 and above. This offer has however been rejected by Unison, further updates will be provided when received.
